1. Comment by the General Public: Pursuant to NRS 241.020(2)(D)(3)(I & II) this time is devoted to comments by the general public and discussion of those comments. A. *Mayor Dana Holbrook: I would like to make a comment that we did have a fire at the Sparks house last night I see there are some go fund me accounts and some donations being taken around town positive saying that the citizens of Carlin we're here to help Carlinites and the fire department, everybody responded nobody was hurt. So it's a sad time but a good time for Carlin to remember that we have neighbors that has some problems. So that covers my point.*

B. *Thomas Burney: Thomas Burney for the record 317 Main to build on what you was talking about there Mister Mayor, the community and helping each other out and stuff like that I'm a little concerned here if we have missed a council meeting for good reasons I understand that, but in point of fact you know there one item here, there is three (3) businesses here that closed last month one of them that comes immediately to mind is Scott's. I am very aware that there are people in this town that cannot afford to get to Elko. The seniors got a bus there are people in this town that are going to be lacking access to Fresh Produce and other amenities because*

*they cannot afford it. I literally am aware in the past people have mentioned to me I haven't been to Elko in six months, we can't afford to go. Um you missed it but I have accused this board of one thing and one thing only in spite of all my other irritation, aggravation, and unhappiness. The only other thing of accused this board of is a lack of imagination. We got seniors up there with two buses. Maybe the City needs to own one of those buses guarantee to use it as a backup for the city council, I don't know if that can be done, that is not my place necessarily to go do that unless I am directed to by a city council, appoint you a council one, find out what you need to find out. When that originally came about when I originally made that statement we wouldn't have a pool in this town, I'm told that we're the only town on Interstate 80 in the State of Nevada that does not have a swimming pool. There were reasons stated for that, the construction to purchase for pool was not a reason why we didn't have a pool I was told that we don't have a pool because we cannot afford the insurance be that as it may or not that is just what I was told ah in point of fact there was no excuse for why we don't have a summer bus for these kids to get to town to go swimming. If we are not going to have a swimming pool here imagination how many buses we see go by here empty in the morning from the mines they make a pic they come out here empty from Elko pick up here take people out to the mines come back into town dumb people off and drive back to Elko empty. Shouldn't somebody be touching base with the bus company, what can you do for us and what's it going to cost. We also low and behold we have sometime called Get My Ride they have been twice on the news the last 2 weeks they aint in the phonebook there is no way to contact them without going to the Frontier information and you get a you know a City and State that you want how to get ahold of them, you call down there and the phone rings and rings and rings. A message comes on that says we are here until 5:30; it is a quarter after three. They are running scheduled buses to Spring Creek hang on a minute it is almost as far from downtown Elko to Spring Creek as it is to Carlin and it is all flat, so I am going to bet you that it probably cost less money to run a bus here we are paying taxes into that county transportation system. Hum, hello what are we doing and I get it we are all busy and stuff like that and but this is kind of the point, we are all in this together. If I wasn't here standing you telling you about you about this you would be going home tonight not knowing wouldn't you. I'm not meaning that as a fault I'm not. It takes all of us. There has been some other stuff you know, continuing issues hum and some new ones, low and behold it has gotten to the point where I am kind of developing the perception that the community of Carlin is considered a support for the City of Carlin it is supposed to be the other way around. The City of Carlin is supposed to be supporting this community. I think we are a little bit shy of the mark. I'm not going to say this out now but if I look over the last five years and what I can point to that this City has done for this community versus 2 police cars, road graders that put in 6 or 8 hours service in a year, a dozen different things it is not sorting out like I think it should hum.*

- D. Thomas Burney: We can do better we can all do better. And I include myself in that. And if that is the case of you know the mayor and the council appoint a committee to go and look at something even if it's a committee one, Mr. Burney you go ask Get My Ride, how come we're not here or if I want to be polite I'll say what have you done*

- to see to it to the city service for the tax payers of Carlin I'd have to get some direction to be polite I think I'm annoyed, I'm annoyed*

So I am really thankful for that. I can't tell you how hard it was to leave the store and know there was nothing there and know there wasn't going to be anything there for a while and hum I have had phone call after phone call about from people saying I can't go to town have no way to go to town and I can't do anything about it you know there's nothing you can do except can I get it for you and that's about it I'm really glad to be able to tell you that this news has been really it was really important for me to get this news because it made me feel like that it wasn't such a bad thing that we did after all. So just wanted you to know that it's coming it should be here in June and very excited about doing it so I think we are going to be okay after all, thank you.*

Thomas Burney: so the last issue would be communication when are they going to be in the phone book, they do tell you can go on line or you can go on face book and stuff like that, you know this idea that we all facebooking I know a lot of City communications from Public works and stuff goes on facebook lot of us don't do that and I am not going to
- U. Mayor Dana Holbrook: and I know that she commented that there was only two veterans cause right now they have a veteran and there is only two veterans in Carlin that has been utilizing that service sense she thought it was very underutilized for Carlin, so there again we talked a little bit about the community we got to get the communication out that there is that service available
- V. Thomas Burney: that has been an ongoing sore point for a lot of issues in the City's communication, myself I consider number one.

- Y. Mayor Dana Holbrook: hopefully we will get thing out there sooner than later issues cause it is I know personally it's a hardship the store and going in and getting it and I have a ride, my wife works in town and I cannot imagine the people that don't have ready access to the store.
- Z. Thomas Burney: quite frankly it been dominoes sense the bank left I know I have been told how much the store was hurting when the bank closed because people now had to go to Elko, I have to go to Elko for my bank business, but I have to go there it is what it is
- AA. Mayor Dana Holbrook: and as Donnetta mentioned there is very positive news
- BB. Thomas Burney: awesome
- CC. Mayor Dana Holbrook: yes so
- DD. Thomas Burney: awesome news is also not getting out
- EE. Mayor Dana Holbrook: ya so I thought that one had because boy I heard it and everybody I talked to already heard it, so ya hopefully that is, goes smoothly and fast
- FF. Councilperson Jay Duke: I think people has to be cautious until you sign on the dotted line and not get hope up so through that process and going back to Get My Ride I think the process has been initiated so there is a time frame there that needs to happen so allow that to happen

- I. *Thomas Burney: Kegan, Kegan yes, they all look alike, hum but in point of fact that one thing I did not relay, that young man, I could not in good conscious say that he was the one that you know drove there before seven o'clock three times and stopped out by our house rapping his pipes, I didn't see him specifically but he did admit that he did it but you know he was talking to me, so I refuse to make an issue out of that, it wouldn't be honest hum the one thing that he did relay to me is yes he confirmed what a city official told me is that it's become a game in town, lets go down and annoy them people down there and and so how do you classify that, is it gang activity, it's a concerted effort hum it just the dust the like I say they come down the street just circle, drive up through there, the incident where the guy, I had twice spoken to an officer about him this has been last April, last, you know before spring, he was deliberately cutting across the property there with me standing there you know defying me to do anything he comes through one time and throws trash out in my yard and I describe the vehicle exactly to a tea, I never heard a word back, it has gotten so bad that not everybody in town is you know grinding on us, I had an acquaintance just a casual acquaintance walk up to me and say its so and so that threw that trash I know exactly who it was, well the only way that this person could have known there was an issue, is if a policemen would have mentioned it to her, that person, but they won't talk to me , I've had somebody come up to me and say Mr. Burney, there in the hall way outside where the police glass is, I cannot describe to you how appalling it was to hear those officers and police people stand there in that office and say things that I refuse to repeat and laugh and making fun of you and saying just terrible, terrible thing, they should not be doing that, you know kay I get it, you can't respond, it probably be a good idea if you didn't, I am not happy about this, I huh, people are thinking ill of me and yet there is, they are not meeting my standards, you are eating in a bed some of these little monster, you have done nothing and um, there has been some officers that have gone down there and made it an effort, I made the comment here, you don't have a police department but you do have some police men, I will be the very first one to to say that, but hum, you know, Dennis want to come up here and repeat to you those comments that he was a part of, would he come up here and put on the record some of those things, I I have to admit, I don't know what was said but I trust the person that said this stuff and huh their a senior and a they came from a time when they wouldn't repeat that stuff, so I don't expect them to and that is why I am not going to name them because I am not going to put them on the spot like that, but I am willing to bet that Dennis won't come up here and repeat some of the stuff that was said, so I don't know how you're going to deal with this, I, I've got some thought going on down the road on some stuff, huh, I got a couple of meetings after thanksgiving, hum, I'm going to go my own way, I've made myself available, I get it that you can't make comments, I thought you was able to ask questions in public comment, you know it's been done, maybe done wrongly, so whatever it doesn't matter, in point of fact, the opportunity that I have offered myself to sit down, let's discuss what happened here, let's figure out what we're going do and if something comes out of it private meetings I don't feel it is a place for me to come do some of this stuff that I choose not to do because I don't think that this microphone is the appropriate place, I accused Dennis of being out of line when he did it to me, um you know so, I am kind of disappointed cause a we could have talked about some stuff, decided what we're going to bring to council, I think that might have been a lot better way to go, but I may be too late I don't know, thanks good night*
- J. *Mayor Dana Holbrook: thanks for your comments*

- K. *Doug Martin: Doug Martin I just thought of something else, as bush street goes out of town before it comes into 278, they had extended the twenty five mile an hour speed zone to the west another quarter a mile or so and along with that speed zone sign they put up a sign to the effect of hum we value our children or whatever drive carefully, does anyone here know who's idea that was?*
- L. *Jay Duke: I don't know but it was a great idea because no one ever use the thirty five, I travel that road every day I am sorry I aint supposed to make any comments but thank you for whoever made that suggestion*
- M. *Mayor Dana Holbrook, Doug Martin and Councilperson Jay Duke: (are all talking at the same time)*
- N. *Doug Martin: I don't know if there is a plan but I am hoping there is a plan to put those signs where the speed zones signs are for the school area both on Bush and on Chestnut and let someone that is traveling through know that we do value our children and it's fifteen miles an hour, I think it is an excellent idea so I guess nobody here had anything to do with it huh? That is truly amazing maybe it's the State anyways if you choose to you might suggest that those signs additionally be put up in the school zone might help in your school zone*
- O. *Mayor Dana Holbrook: Thank you Doug, any other public comment, alright we will move onto the last agenda item which is #11 which is adjournment*
